Sub: Reply to the letter dtd. 12.03.2013 allegedly sent by few members of the Gulbarg

Co-Operative Housing Society Limited.

## Dear Sir,

- 1. We, the member. of the Gulbarg Co-Operative Housing Society Limited, henceforth to be referred as 'the society' in brief for the sake of convenience, have learnt about a letter purported to have been sent to you by few members of our society. We therefore find it bit urgent to respond and we do so by way of this letter.
- At the outset we, the undersigned are members of the 'the society' state that we have full faith in the NGO namely 'Citizens For Justice & Peace' and all its trustees, including Ms. Teesta A. Setalvad. Mr IM Kadri Mr. Javed Anand and others. This NGO has stood by us in most difficult period.
- 3. We, the undersigned, members of 'the society' categorically deny the allegations leveled in the letter dtd. 12.03.2013 which is nothing but bunch of lies so as to mislead the victims of the infamous 2002 Gujarat riots. It is admitted fact that this NGO has

helped the victims of the offence registered as CR No. I-67/2002 registered with Meghaninagar Police Station, Ahmedabad as more than 69 persons were killed. Most of those who have signed the above mentioned letter were quiet satisfied with the help and appropriate assistance provided to them so as to enable us to ensure justice. On 08.06.2006 a complaint has been sought to be filed by Ms. Zakia Jafir, widow of slain MP Mr. Ahsan Jafri and mother of one of the signatories to this letter namely Mr. Tanvir Jafri. The Hon'ble Supreme Court had directed the SIT to 'look into' the complaint and as per subsequent orders, the report of the investigation filed by the SIT cannot be accepted by the Ld. Magistrate without giving opportunity of hearing to the complainant. The pursuant to the recent order of the Hon'ble Supreme Court dtd 07.02.2013 the SIT is directed to supply relevant documents to the complainant and the protest petition be heard after 8 weeks thereafter. Thus, the final date for hearing the protest petition is fixed as 15.04.2013 before the Ld. Metropolitan Magistrate, Court No. 11, Ahmedabad. We are writing this to make it clear that this belated request for a complaint is nothing but 'relentless' efforts of the influential accused to thwart the process of justice as the complaint dtd. 08.06.2006 is investigated and the final arguments of the 'protest' petition is fixed on 15.04.2013.

- 4. On bare perusal of the application/ letter dtd. 12.03.2013, seeking registration of the complaint against the NGO, it becomes clear that the same is written by the forces who have been motivating Mr. Raiskhan Pathan for filing complaints after complaints against this NGO namely 'Citizens for Justice & Peace' i.e., CJP in brief.
- 5. The authors of the letter dtd. 12.03.2013 be put to strict proof with regard to the authenticity and the source of the information narrated by them in the letter. The signatories should mention as to how they obtained the details of the account numbers and the amount etc mentioned in the said letter.

- 6. We state that the NGO has already authorized the society to sell the property last year and therefore there cannot be any grievance against the NGO as the society has not parted with any part of the land. A formal resolution to this effect has also been passed by the society. Moreover, the donors don't feel cheated and therefore the signatories, who have not parted with a single pie, have no locus to file any such complaint against the NGO. The ingredients of the offence of 'cheating' and 'breach of trust' are not contained in the allegations as nothing is 'parted' by anybody from the society. We therefore strongly oppose any move to accept such a frivolous complaint sent to the police on 12.03.2013.
- 7. We, the members of the society categorically state that the NGO, was asked to make a museum of resistance in the Gulberg Society after more than four years of the offence of mass carnage. The society had no purchasers and under the circumstances when the NGO accepted the proposal of purchasing entire Gulberg Society, naturally all the members readily accepted. However, with the rise in prices few members have demanded release of their property so that their property can be sold of. In and around October, 2012, the society has been permitted to sell the properties if appropriate price is offered. Thus, we have no grievance whatsoever against the NGO.
- 8. The complaint dtd. 12.03.2013 carries signatures of those who are not even the share holders of the 'society'. It would be pertinent to note the details of the signatories. The first signatory no. 1 is Firozkhan Saeedkhan Pathan, no. 2 is Imtiazkhan Saeedkhan Pathan, no. 3 is Pathan Saeedkhan Ahmedkhan who are father and sons. The signatory no. 10 Rashidkhan Ahmedkhan Pathan is real brother of Saeedkhan, no. 11 Aslam Anwarkhan Pathan is nephew of Pathan Saeedkhan Ahmedkhan i.e., no. 10. The signatory no. 6 Suraiyya banu Aslam khan is wife of no. 11 Aslamkhan. All these people reside in bungalow no. 18. The signatory no. 9 Mrs Sairabanū J Sheikh resides in

bungalow no. 9 who is not named as a owner of the bungalow as per law. The signatory no. 4 Mohammed Sharif N. Sheikh is resident of bungalow no. 17 but neither the bungalow is in his name nor is he a share holder of the society. Thus, she cannot be considered to be a member of the society. The signatory no. 5, Pathan Yusufbhai Baderbhai had been residing on 3rd floor of the flats situated in the society. The signatory no. 7 Fakir Mohammed had been residing on the 1st floor of the flats situated in the society. The signatory no. 8 Mohammed Ali is grand son of Fakir Mohammed and had been residing on the 1st floor of the flats situated in the society. Thus, these 3 signatories at sr. no. 5, 7 and 8 are not even the members of the society. Thus, the letter pad of the society is being misused by the signatories of the letter dtd. 12.03.2013.

9. Appropriate action should be initiated against the signatories of the letter dtd. ·12.03.2013 as they have been trying to mislead the police machinery with a view to 'thwart' the order of the Hon'ble Supreme Court Court of India dtd 12.11.2011 followed by the order dtd. 07.02.2013 whereby the protest petition is likely to be heard after filing on 15.04.2013. Accused in the complaint regarding which the protest petition is to be heard are the most powerful in the state. It is because of this ulterior motive the complaint is sought to be filed at this stage. Thus, this complaint is nothing but one more effort to prevent the NGO from providing legal assistance to the victims at a critical stage in the justice process.
