- The Memorandum and Articles of Association with the Objects of the CJP were annexed therein, as Appendix B (Self Attested Pages Nos 1-13). The Memorandum and articles of association of Sabrang Trust had been made available earlier (Running Pages Nos 626-631, annexed to affidavit dated 18.6.2014, CRMA 4677/2014, Gujarat High Court record)

Second Appearance before the Police and Submission of Documents (January 5-6.2015): With a written communication, the Petitioners submitted as Exhibit II Colly, , the following documents:

 A Self-Attested Copy of Details of all Institutional Donors to both Trusts in their FCRA Accounts, i.e. Citizens for Justice and Peace (CJP) and Sabrang for the relevant period for this investigation i.e. from 2007-2008 to 2011-2012.

- 10. The Petitioners would like to state that even prior to the registration of the FIR on 4.1.2014, the Trustees of Sabrang Trust and Citizens for Justice and Peace (CJP) had fully cooperated when letters were received from the Crime Branch. The first set of letters from DCB Crime Branch which are dated 18.03.2013, 8.05.2013, 08.05.2013 addressed by PI C.B. Gamit, SOG Crime Branch have been replied to with letters dated 13.03.2013, 26.03.2013 and 20.05.2013.
- 11. That on April 11, 2015, another letter was received from the IO asking for more documents. These are:
- The data back up in Tally software readable format for the period 2007 to 2014 related to all the accounts of Sabrang Trust and Citizens for Justice & Peace [CJP] including SB, FCRA, HRD Accounts.
- ii. The data back up in Tally software in readable format for the period 2007 to 2014 related to all personal accounts of Ms. Teesta Setalvad and Mr. Javed Anand.
- iii. Soft Copies of Balance Sheet and Income and Expenditure account of both the Trust namely CJP and Sabrang compiled on EXCEL, not PDF Files.

Trust Deeds of Both trusts, proposal & project reports to Foundation, STADT NUREMBERG, GERMANY, Ministry of HRD, United Nations Voluntary Fund for Victims of Torture administered by the Office of the United Nations High Commissioner for Human Rights, Geneva. Please give the supporting documents to support the expenses of Rs 17.84 lacs, the appeal brochures circulated for conducting the concert and the objective beyond the concert as documented by you in the advertisements appeals and request.
- ix. Resolution dated 05/01/2008 in respect of Gulberg Society passed by the members of Sabrang Trust.
- x. Minutes of the meeting wherein the proposal for the ART Auction was allowed/ passed.
- xi. You have collected funds for providing legal and financial assistance to riot victims. Please provide a Certificate from the Chartered Accountant certifying the money expended on specific beneficiaries with names and addresses and contact details of all the beneficiaries.

- xiv. Subsequent to the commencement of the investigations you have deleted or rendered inaccessible the 'About US' page and the page related to the Art Auctions from your website. Please furnish certified copies of the data which was uploaded on these pages before deletion.
- 12. The Petitioners are currently in the process of compiling the documents and have already written to the IO seeking for a reasonable time of 10 days to submit the documents. Thereafter, the Petitioners requested a further 10 days to which the Petitioners received a response asking them to ensure documents are supplied within seven days i.e. by May 8, 2015.
- 13. That a large part of these documents do not concern the present investigation. The Petitioners are unable to cope with these unreasonable demands as any questions asked by them regarding the scope of investigation or the need of certain documents in that scope, is construed as non-co-operation to be used against them in the proceedings of anticipatory bail. It is submitted that it is clear that the whole process of the investigation is primarily for the purposes of harassment of the Petitioners with no interest in furthering the investigation. For example the IO has asked for the following documents:

- 14. That it is submitted that the aforesaid documents illustrate that the investigating agency is seeking documents from the Petitioners which are beyond the scope of the FIR or the allegations made therein. None of the donors have made any

complaints of mis-management of finances and utilisation certificates have been made available to them for the funds utilised.

- 15. That the documents supplied to the Respondent were always with a covering letter giving an index of documents attached. The correspondence between the Petitioners and Respondent is annexed herewith as follows:

The Petitioners say and submit that from a perusal of all the accounts, the bifurcation of the monthly credit Card statements supported by relevant bank statements of the trusts, personal bank statements and all corresponding documents, it is evident that the allegations about expenses of a personal nature being reimbursed by the trusts is totally baseless.
- 17. That the Petitioners submit that the Respondent State is trying its best to prove the allegation of non-co-operation and to this end is making unreasonable demands on the Petitioners. These demands would compel the Petitioners to refuse to part with those documents which the State can label as "non-co-operation". It is submitted that even when the Petitioners ask for time to supply the documents, the IO is writing back to the Petitioners that they are not co-operating. Annexed hereto and marked **Annexure- P-18** is a copy of the letter dated May 1, 2015 received by the Petitioners from the IO wherein he is stating that the Petitioners are not co-operating.

18. That the Petitioners are also concerned with efforts of the State in compelling to

furnish the details of individual donors who have supported the cause of the

Petitioners. It is submitted that a lot of sympathizers/ persons who felt outrage at

atrocities committed during the 2002 communal mass crimes in Gujarat have

contributed to the Petitioners after seeing their work in supporting the victims.

The Petitioners submit that disclosing their names would perhaps expose them

to the systematic targeting by the State as is being done currently in the case of

Ford Foundation. In any event, this information is beyond the scope of the

present investigation and cannot be sought from the Petitioners.

19. That the application is bona fide and made in the interests of justice.

20.In the facts and circumstances stated hereinabove, it is Most Respectfully

prayed that this Hon'ble Court be pleased to:

a. direct the Respondent State to disclose to this Hon'ble Court the scope of

investigation in the present case;

b. and pass such other order or orders as this Hon'ble Court may deem fit in the

facts and circumstances of the case.
