They had been burnt alive all the our societies persons including with my family and also burnt the houses. The others name will be send, when I remember. This incident was occurred at something 1 to 1.30 hours, afternoon.

Therefore, the above mentioned mob had been burnt my house and also burnt alive my families members. The aforesaid mob were also burnt to the houses, shops of our community. To be desire of the mob that, burnt alive the houses and the shops of our community and also burnt alive the societies persons. They made an illegal company and they had been role of the conspiracy by Stone - pelting, Petrol-bomb, Bottles of the Glasses

and burning Kakda also pelting to us. The mob had been to imprison the persons of their houses and then burnt alive all of them in their houses. The mob of about something 1000 to 2000 had been attacked to our community. These are the dangerous offence in our mind, so that I draft the complaint against to all of them. My witnesses are the persons as mention in the complaint and also who are found in the inquiry.
