Modi's Horror in Gujarat Mumbai NGOs Condemn Bhat's arrest

Mumbai, Oct- 3: Maharashtra based Muslim NGOs express their strong opposition to the recent arrest of honest IPS officer Sanjiv Bhat by the Gujarat Government. After Sanjiv Bhat's bold attempt to file a petition in the Supreme Court, he was being targeted by Modi and company for revealing the truth. He laid bare in the petition, that Modi told him and other police officers at his residence to "allow Hindus to vent their feelings" in reaction to the burning of the train coach in Godhra, in which Hindus lost their lives.

The NGOs leaders said that all peace-long people who wish to see the rule of law prevail and justice meted out to perpetrators of crime are shocked at this latest instance of Modi's ire. It is another blatant attempt to mask his alleged role in the communal conflagration of Gujarat in 2002.

Among Bhat's own police staff, one KD Pant has filed a case of issuing threats, erasing evidence and unlawful confinement of persons against Bhat. It is quite clear that this is an attempt to muzzle his petition pending in the Supreme Court and tarnish his reputation. This is similar to the attempt by Modi to cast aspersions on some social or humanitarian activists -- who had filed or followed court cases against Narendra Modi or his government, and Mr. Modi retaliated by using his both money and muscle power to allegedly buy off people or threat them to change their statements.

Bhat is one among many, like Sri Kumar former IPS officer, who have faced the full force of Modi's vindictiveness, for they have raised questions about the 2002 genocide in Gujarat as well a series of fake encounter killings of innocent persons, both Muslim and Hindu.

The real truth about Modi's own minister, Hiren Pandya, might never be revealed but his widow is pursuing his case in the Supreme and seeking justice of the dastardly killing of her husband, allegedly at the instigation of Mr. Modi.

We strongly appeal to all peace loving people to raise their voice against the black deeds of Modi. His recent sadbhavna fast was a farce and was meant to lure the gullible that he could be a prime ministerial candidate for the BJP.

The sensible public being well aware of the Modi's alleged involvement in a long history of crimes in Gujarat has the gumption to nurse ambitions of India's PM. Let alone his being a candidate for India's prime minster, his chief minister-ship in Gujarat is under serious question.
