Gujarat Police Investigating Officer had filed Three Charge Sheets (50 and 23 and 6 accused respectively) SIT. Before the constitution of the SIT, the trial in respect of the above referred offences had already commenced and 52 witnesses had already been examined by the Trial Court. After the Constitution of the SIT on 26.3.2008 and upon further investigation, two different charge sheets were filed. In addition to the 79 accused named earlier, Four More accused including the then Investigating Officer were charged as accused. The Total Accused in this case are now 83.

During the course of the trial, Exhibit 656 in Sessions Case No 180/2002 was preferred by the Complainant under Section 319 of the Indian Penal Code requesting the Trial Court to add (1) Prahladbhai Mohanbhai Gosa (then MLA) and (2) Dahyabhai Tribhuvandas Patel as accused. The Trial Judge B. Karia, after recording the evidence of PW-81, Mohammed Iqbal Ahmedkhan Baloch) at Exhibit 568, PW-89 Shabirmiya Hussainmiya at Exh 85, PW-97, Mohammed Hanif Dalubhai Sindhi at EXH 613, PW 104 Ahmedmiya Hasumiya Belim at Exh 630, PW 113, Sher Mohammed Dalumiya Sindhi at Ex 645 and other witnesses, passed an order dated **10.2.2010** allowed the Application and the two accused were arraigned. On June 17, 2010, Judge Anant Dave upheld the Trial Court Order arraigning the two accused.
