To summarise, there are still several cases related to Gujarat pending before the Hon'ble Supreme Court. The first writ of the NHRC in the BEST Bakery case has been converted into a PIL (public interest litigation) on the issue of witness protection, police reform and role of the public prosecutor(Item 1 in the Table)

It is Item 2 and 3 of the table above that concern us *related to specifically the demand for transfer of investigation to CBI and transfer of trials out of state of Gujarat.* It is in the Transfer Petition Filed by the National Human Rights Commission (NHRC) that the *Citizens for Justice and Peace (CJP)* has become a party and filed 65 odd affidavits of victims and eye witnesses. It is in this Transfer Petition [T.P.(Crl.) No. 194-202 of 2003 & 326-329 of 2003; National Human Rights Commission Versus State of Gujarat & Ors.—Item 2 in the Table above] that the **Supreme Court has stayed the criminal trials on November 21, 2003.**

When these matters repeatedly came up for hearing, attention has been drawn to Item 3 [W.P. (Crl.) No. 37-52, Devendrabhai Pathak & Ors. Versus State of Gujarat & Ors.] supported by *the CJP*, *f*iled in May 2002 asking for transfer of investigation to the CBI. This petition is also pending hearing.
