MOST RESPECTFULLY SHOWETH:

- 1. That the present Writ Petition is pending before this Hon'ble Court.
- 2. That the Applicant/Intervener Citizens for Justice and Peace (CJP) is a public trust established under the Bombay Public Trusts Act, 1950 and has been working to further the civil and political rights of Indian citizens since its establishment in 2002. The Applicant/Intervener works on issues of constitutional rights of all Indians, various Minorities, Adivasis, forest dwellers and for the citizenship rights of genuine Indian citizens of Assam. It has been working constructively in 19 districts of Assam



since 2018 with Volunteer Motivators, Community Volunteers and a State Helpline Centre to reach legitimate legal aid to the unlettered and marginalised who are victims of exclusion due to unfairness or bureaucratic negligence.

- 3. That the applicant has already filed an Application for Intervention being I.A. No. 117074/2019 which was disposed when the material judgement relating to the National Register of Citizens (hereinafter referred to as "NRC") was passed on 13.08.2019 by this Hon'ble Court.
- 4. That the present Application is being filed by the Applicant/Intervener in a representative capacity in order to bring to the notice of this Hon'ble Court the manner in which the Final List published on 31.08.2019 has unreasonably and unfairly excluded the names of certain sections of persons which essentially results in violation of the basic principle of family unification by excluding members of a family. The present application concerns cases of children even when their parents and, in some instances, the relatives/guardians of the children are part of the NRC.
- 5. That the work of the Applicant/Intervener has included running a Toll Free Helpline for over five months that logged in close to 9,500 distress calls from the far-flung areas of Assam. In the process of this work, thousands of distressed and unlettered persons who did not possess the wherewithal to negotiate a complicated bureaucratic process were assisted by the Applicant/Intervener. The Applicant/Intervener places before this Hon'ble Court a sample list of approximately persons from far-flung districts of Assam who were assisted by the Applicant/Intervener's Assam Team after they called for assistance.

This list, which for the sake of brevity only has names, gender, ages, economic profile and the respective village at this stage, is not exhaustive but illustrative, and the number of persons assisted is actually much higher and runs into the thousands. A true and correct copy of the sample list of 154 persons (approx.) from various districts of Assam who have been assisted by the Applicant/Intervener's Assam Team is marked and annexed herewith as ANNEXURE A-1 (Page No. 99 to 26).

6. This work which still continues on a month to month basis under difficult circumstances amounts to providing para-legal aid to marginalised sections of the rural population, 62% of the affected of which are women. It is in the context of this intense involvement that the present Application is being filed to draw this Hon'ble Court's attention to the manner in which the NRC Final List has unreasonably excluded the most vulnerable section of the population - children. This work that has taken place in far-flung and often unreachable areas of the State have drawn upon the support of several right-thinking individuals, academics and writers who have been witness to this ground-breaking work. It is because of the inaccessibility of the topography of the State to vast sections of the marginalised and agrarian population that the idea of a Toll Free Helpline number was conceived. This mechanism was successful and ran for 5 months, allowing people to contact the Team for adequate assistance to file their Claims in the correction process before the NRC. There was a lot of panic, fear and distress among vast sections of the population when as many as 40 lakh (4 million) persons were left out of the NRC Provisional List (31.07.2018) and it is following this that the Applicant/Intervener's ground team got to work providing counselling and real time aid to the people affected. There have been a



distressing number of deaths caused due to the fear and anxiety that this crisis has unleashed and, therefore, this work was crucial as a humanitarian task.

- 7. That the Applicant/Intervener submits a brief history of the issues surrounding the citizenship provisions as recognized within the Constitution of India. It is submitted that these submissions have been made by the Applicant in the Application for Intervention filed previously i.e. I.A. No. 117074/2019. However, for the sake of convenience certain portions are being repeated herein:
 - a. India gained independence on 15.08.1947 through an enactment of the British Parliament i.e. the Indian Independence Act, 1947. This enactment divided British India into two nations i.e. India and Pakistan. Subsequently, in the year 1971, East Pakistan emerged as a sovereign nation i.e. Bangladesh.
 - b. On attainment of independence, the Drafting Committee submitted a Draft of the Constitution of India to the Constituent Assembly. Articles 5 and 6 were provisions dealing with citizenship. These two provisions as contained in the original draft are reproduced hereunder:
 - "5. At the commencement of this constitution-...
 - (a) every person who or either of whose parents or any of whose grand-parents were born in the territory of India as defined in this constitution and who has not made his permanent abode in any foreign State after the first day of April, 1947; and
 - (b) every person who or either of whose parents or any of whose grand-parents was born in India as defined in the Government of India Act, 1935 (as originally enacted), or in Burma, Ceylon or Malaya, and who has his domicile in the territory of India as defined in this Constitution, shall be a citizen of India, provided that he has not acquired



the citizenship of any foreign State before the date of commencement of this Constitution.

Explanation: For the purpose of clause (b) of this article, a person shall be deemed to have his domicile in the territory of India— ...

- (i) if he would have had his domicile in such territory under Part-II of the Indian Succession Act, 1925, had the provisions of that Part been applicable for him, or
- (ii) if he has, before the date of commencement of this constitution deposited in the office of the District Magistrate a declaration in writing of his desire to acquire such domicile and has resided in the territory of India for at least one month before the date of the declaration."
- "6. Parliament may, by law make further provision regarding the acquisition and termination of citizenship and all other matters thereto."
- c. The aforesaid draft Articles dealing with citizenship were not adequate to address the situation that prevailed at that time. It only addressed the conferment of citizenship to those who had their domicile in the territory of India as defined in the Constitution. It did not take into consideration those who had migrated to India from Pakistan or those who migrated to Pakistan but came back to India thereafter. The Drafting Committee could not apprehend the consequences of communal riots that took place in India and Pakistan. Lakhs of people had migrated from Pakistan to India and thousands from India to Pakistan. The original Draft had not made any provision for those persons. As a result, when this Draft was placed before the Constituent Assembly, there was extensive debate for due modification.



d. To elaborate further on this point, proposed amendment for Articles 5 and 6 were placed before the Constituent Assembly in the following manner:

"That for articles 5 and 6, the following articles be substituted-

'5. At the date of commencement of this Constitution, every person who has his domicile in the territory in citizenship at the date of commencement of this constitution.

India and -

- (a) who was born in the territory of India: or
- (b) either of whose parents was born in the territory of India: or
- (c) who has been ordinarily resident in the territory of India for not less than five years immediately preceding the date of such commencement, shall be a citizen of India provided that he has not voluntarily acquired the citizenship of any foreign State.

Rights of citizenship of certain persons who have migrated to India from Pakistan-

- 5-A.- Notwithstanding anything contained in article 5 of the Constitution, a person who has migrated to the territory of India from the territory now included in Pakistan shall be deemed to be a citizen of India at the date of commencement of this Constitution if-
 - (a) he or either of his parents or any of his grandparents was born in India as defined in the Government of India Act, 1935 (as originally enacted); and
 - (b) (i) in the case where such person has so migrated before the nineteenth day of July 1948, he has ordinarily resided within the territory of India since the date of his migration; and
 - (ii) in the case where such person has so migrated on or after the nineteenth day of 1948, he has registered as a citizen of India by an officer appointed in this behalf by the Government of the Dominion of India on an application made by him therefore to such officer



before the date of commencement of this Constitution in the form prescribed for the purpose by that Government.

Provided that no such registration shall be made unless the person making the application has resided in the territory of India for at least six months before the date of his application."

"Rights of Citizenship of certain migrants to Pakistan-

5-AA. Notwithstanding anything contained in articles 5 & 5-A of this Constitution a person who has after the first day of March 1947, migrated from the territory of India to the territory now included in Pakistan shall not be deemed to be a citizen of India:

Provided that nothing in this article shall apply to a person who, after having so migrated to the territory now included in Pakistan has returned to the territory of India under a permit for resettlement or permanent return issued by or under the authority of any law and every such person shall for the purpose of clause (b) of article 5-A of this Constitution be deemed to have migrated to the territory of India after the nineteenth day of July 1948."

"Right of citizenship of certain persons of Indian origin residing outside India-

5-B. Notwithstanding anything contained in article 5 and 5-A of this Constitution, any person who or either of whose parents or many of whose grandparents was born in India as defined in the Government of India Act, 1935 (as originally enacted) and who is ordinarily residing in any territory outside India as so defined shall be deemed to be a citizen of India if he has been registered as a citizen of India by the diplomatic or consular representative of India in the country where he is for the time being residing on an application made by him therefore to such diplomatic or consular representative, whether before or after the commencement of this Constitution, in the form, prescribed for the purpose by the Government of Dominion of India on the Government of India

[&]quot;Continuance of the rights of citizenship-



- 5-C. Every person who is a citizen of India under any of the foregoing provisions of this Part shall subject to the provisions of any law that may be made by Parliament, continue to be such citizen.
- e. There is a difference of wording that must be noted in Article 6 which was part of the original draft and which was incorporated in the Constitution of India as Article 11. The original draft is quoted hereunder:
 - "6. Parliament may by law, make further provision regarding the acquisition and termination of citizenship and all other matter relating thereto."

On the other hand, the amended provision incorporated as Article 11 in the Constitution of India is quoted hereunder:

- "11. Parliament to regulate the right of citizenship by law:Nothing in the foregoing provisions of this Part shall derogate
 from the power of Parliament to make any provision with
 respect to the acquisition and termination of citizenship and all
 other matters relating to citizenship."
- 8. That the Parliament while enacting the provisions of citizenship was empowered to make a new law embodying new principles. In exercise of the powers under Article 11, Parliament enacted the Citizenship Act, 1955 (hereinafter referred to as "the 1955 Act") bringing in elaborate provisions for acquisition and termination of citizenship. After the amendment of the 1955 Act in 2004, the provisions of citizenship by birth as embodied in Section 3 of the said 1955 Act read as follows:
 - "3. Citizenship by birth
 - (1) Except as provided in sub-section (2), every person born in India,—
 - (a) on or after the 26th day of January, 1950, but before the 1st day of July, 1987;



- (b) on or after the 1st day of July, 1987, but before the commencement of the Citizenship (Amendment) Act, 2003 and either of whose parents is a citizen of India at the time of his birth;
- (c) on or after the commencement of the Citizenship (Amendment) Act, 2003, where—
 - (i) both of his parents are citizens of India; or
 - (ii) one of whose parents is a citizen of India and the other is not an illegal migrant at the time of his birth, shall be a citizen of India by birth.
- (2) A person shall not be a citizen of India by virtue of this sec-tion if at the time of his birth—
 - (a) either his father or mother possesses such immunity from suits and legal process as is accorded to an envoy of a foreign sovereign power accredited to the President of India and he or she, as the case may be, is not a citizen of India; or
 - (b) his father or mother is an enemy alien and the birth occurs in a place then under occupation by the enemy."
- 9. That the process of finalisation of the NRC has been closely monitored by this Hon'ble Court since 2009. It more actively began in 2013 with orders relating to the implementation of the process being passed. On 31.08.2019, under this Hon'ble Court's directions, the NRC Coordinator published the NRC Final List for Assam which excluded 19,06,657 persons. The status of the excluded persons and the future course of action is, at present, unclear.
- 10. That vide order dated 23.07.2019, this Hon'ble Court had directed the learned State Coordinator to issue a public notice to enable stakeholders to assist this Hon'ble Court with respect to certain issues. The Applicant/Intervener herein had filed I.A. No. 117074/2019 pursuant to said order in order to bring to the notice of this Hon'ble Court the situation as it persists on the ground as well as the legal



untenability of the State Coordinator's suggestion to exclude persons born in India prior to 30.06.1987 on the grounds that one parent of such person is either a Doubtful Voter (DV), a Declared Foreigner (DF) or a person whose claim for citizenship is pending before a Foreigners Tribunal (PFT). This Hon'ble Court, vide order dated 13.08.2019, had referred the aforesaid issue to a Constitution Bench for determination.

- 11. That at the time of the filing of the present Application i.e. almost 3 months after the publication of the NRC Final List, the State of Assam is in the midst of a humanitarian crisis as a direct result of these mass exclusions. Presently, the 19 lakh persons excluded live with the sword of statelessness hanging over their heads with no reasons having been supplied to them for their exclusions. Appeals of all 19 lakh persons will now have to be filed within the stipulated period of 120 days before the respective Foreigners Tribunals. This process cannot begin as the 19 lakh persons who have been excluded have not been given the reasons for their exclusion. In order to file an appeal before the Foreigners Tribunals, each person requires a certified copy of the exclusion order and list of documents submitted to the NRC. Furthermore, it is unclear within which District's jurisdiction and before which Foreigners Tribunal each appeal is to be filed. It is also important to note the issue of accessibility in light of information that these Foreigners Tribunals would be located in six zonal areas in the State.
- 12. That once a person has been declared a Foreigner by a Foreigners Tribunal, he/she may be detained in Detention Centres within the State of Assam. The Applicant's data suggests that almost 100 persons have lost their lives as a direct result of the citizenship issues involved in the publication of the NRC which include 27 recorded deaths in Assam's

Detention Camps. There are already around 1,100 detainees in Assam's 6 Detention Centres located in Goalpara, Kokrajhar, Silchar, Jorhat, Tezpur and Dibrugarh. There are also reports that new facilities have been planned in other parts of the State. It is important to note that on 10.05.2018, this Hon'ble Court had directed the release of those detenues who have completed more than three years in detention.

- 13. That it is of the utmost importance that this Hon'ble Court continues to closely monitor the NRC process even after the publication of the Final List in light of the grave questions of citizenship and rights of the 19 lakh persons involved.
- 14. That this Hon'ble Court has repeatedly held that Articles 14 and 21 of the Constitution of India apply to both citizens and non-citizens. In National Human Rights Commission v. State of Arunachal Pradesh [(1996) 1 SCC 742], this Hon'ble Court held that rights under Article 21 are as much available to non-citizens as to citizens, and to those whose citizenship is unknown. It is pertinent that the Fundamental Rights envisaged under Articles 14 and 21 of the Constitution of India act as overarching principles that govern the NRC process at each step.
- 15. That the grassroots work of the Applicant/Intervener has shown that with the publication of the NRC Final List, specific categories of already marginalised persons have been excluded. These include the following:
 - a. Children excluded from the NRC Final List even as their parents and relatives are included.
 - b. Orphaned children excluded from the NRC Final List who do not reside in State Orphanages or Homes.

- c. Children excluded from the NRC Final List who are from disconnected families and stay with close or distant relatives.
- d. Parents excluded from the NRC Final List when children are included.
- e. Bengali-Hindu refugees who have been excluded in large number despite production of the Refugee Certificate/Refugee Inmate Certificate, the Citizenship Card and/or the Migration Certificate. The reason given for this category of exclusion is that "back end" copies of these documents are not available with the authorities concerned.
- f. Persons excluded by virtue of being declared Doubtful Voter or Suspected Foreigner.
- 16. That the unreasonable manner in which children have been excluded from the NRC Final List even when their parents are included is in direct contravention of the State's obligation towards children as envisaged under Article 15 (3), Article 39 (e) & (f), Article 45 and Article 47 of the Constitution of India, and the Juvenile Justice (Care and Protection of Children) Act, 2015. A true and correct copy of an illustrative list compiled by the Applicant/Intervener of 61 children who have been excluded from the NRC Final List even when their parents and relatives are included is marked and annexed hereto as ANNEXURE A-2 (Page No. 27 to 1).
- 17. That the Applicant/Intervener is giving details from the above list of three instances where families have been divided as a result of the children being excluded to illustrate the arbitrary manner in which the NRC process has been undertaken:
 - a. Amirul Ali (age 10 years and at S. No. 44 in the list), Akramul Islam (age 9 years and at S. No. 55 in the list), Baharul Islam (age 7

years and at S. No. 56 in the list) are three sons of Hasmat Ali (age 32 years) and Amirun Begum (age 25 years) of Village No. 2, Dakshin Makra, P.S. Bijni of Chirang District. The village is far flung area without any proper road communication and it also lies close to the the international border of Indo-Bhutan area. Hasmat Ali is 36 years old at present and his age was 32 years at the time of submission of the NRC Claim Application. Hasmat Ali is a daily wage labourer and seasonal farmer, who ploughs others land during rainy season, but could not earn above Rs. 150 daily. He supports a family of 7 including his father, mother, wife and 3 children. There was a small plot of land in the name of Abdul Khalek (age 60 years), father of Hasmat Ali, which had a permanent patta of 1963. Hasmat Ali along with all other family members who are descendants of Abdul Khalek submitted their NRC application taking the land patta as their legacy document. On the basis of these documents, the parents have been included but their minor children have been excluded. The family attended nine hearings of the NRC out of which two were at the Nagrik Seva Kendra (NSK) level which was located 10 kms.away from their home. At the next stage and as the next step, they attended hearings 3 times in separate hearings at the Sub-Divisional Head Quarters and 4 times at the District Head Quarters, which are both located about 50 kms.from their home. The family had to remain present and also take witnesses with them at their own cost, which in addition to causing loss of earnings, put them in debt. Due to travelling expenditure of his family members and witnesses, he had to borrow Rs. 15,000 as loan from a local money lender, which has increased to Rs. 18,000 till the present date with interest.

- b. In another instance, Narjul Islam (age 13 years and at S. No. 52 in the list), Mijanur Islam (age 12 years and at \$. No. 53 in the list) and Semima Begum (age 16 years) are the two sons and one daughter of Mamon Uddin (age 49 years) and Nurun Nehar (age 42 years) of Village No. 1 Barbari under Dharamtul P.S. of Morigaon District. Barbari is a village which falls under Greater Nellie, where a brutal carnage taking over 2,700 lives had taken place during the Anti-Foreigners Assam movement in 1983. Mamon Uddin is one such victim of the Nellie Massacre who lost his father, mother and 4 younger brothers in the targeted violence. In the updated final NRC, the names of Mamon Uddin and his wife Nurun Nehar have been included but their two children Narjul Islam and Mijanur Islam have been excluded having all valid documents including the linkage certificate which they submitted. Mamon Uddin is an illiterate person and a daily wage earner and living in a very backward village with poor communication and pathetic socioeconomic conditions. Mamon Uddin submitted the legacy data of 1965 voter list as his legacy document which includes his father's name, his own voter ID as his linkage document and school certificates of his two sons as linkage documents between him and his sons. During the entire process of NRC, they attended several hearings. One such hearing was held at Bagulapara under Lahari Ghat P.S. which is 80 kms. from his house. Another hearing was held at Rajgadhuwa, which is about 70 kms. from his house. In the entire process of NRC and attending of hearings, he had to borrow Rs. 15,000 as loan on interest at a rate of 10% monthly.
- c. Masuma Khatun (age 4 year and at S. No. 59 in the list) is the child of Momin Ali (age 30 years) and Mamtaj Begum (age 25 years).

Her father applied for her name in the updated NRC with all valid documents including her birth certificate. Names of father, mother, grandfather, grandmother and uncles of Masuma Khatun have been included in the final NRC but her name was excluded. Her father Momin Ali is a marginal farmer who also works as daily wage labourer. He had attended at least 9 hearings during the NRC process along with his family members, witnesses and the minor child. He had to sell his one cow out of the two cows he had in order to attend the entire process of NRC.

d. Tasmila Khatun (age 10 years and at S. No. 48 in the list), Afjarul Islam (age 7 years and at S. No. 49 in the list), Moriyam Khatun (age 4 years and at S. No. 50 in the list) are the two daughters and one son of Nur Muhammad (age 47 years) and Anuwara Khatun (age 40 years) of Village Mairabhaj under Dhing P.S. of Nagaon District. Nur Muhammad submitted his NRC application with the 1965 voter list as his legacy document, his own voter ID and school certificates of the 3 minor children. The family also includes 3 other sons of Nur Mahammad and Anuwara Khatun i.e. Anarul Islam (age 24 years), Merajul Hoque (age 19 years) and Amirul Islam (age 21 years). Though the names of Nur Mahammad and Anuwara Khatun were included in final NRC, all the 6 sons and daughters were excluded. Nur Mahammad is a marginal farmer having two bighas of land where he ploughs and most of the year he works as a daily wage labourer. In the entire process of the NRC, he has attended NRC hearings several times. One such hearing was held at Jamunamukh which is about 120 kms. far from his home. Another hearing was held at Bebejia which is 60 kms. far from his home. The next two hearings he attended were held at



Mairabari and Dhing which were also about 20 kms. far from his home. Like in the previous instances, the NRC process has reduced Nur Mahammad to a state of penury with huge debts looming over him.

- 18. That the United Nations Convention on the Rights of the Child, which has been ratified by India, makes it obligatory under Article 8 for all State Parties to respect the right of the child to preserve his or her identity, including nationality, name and family relations as recognized by law without unlawful interference. More importantly, Article 9 holds State Parties responsible for ensuring that a child is not separated from his or her parents against their will, except when competent authorities subject to judicial review determine, in accordance with applicable law and procedures, that such separation is necessary for the best interests of the child.
- 19. That this Hon'ble Court may allow the Applicant/Intervener herein to make submissions for proper adjudication of the abovementioned W.P. (Civil) No. 274/2009 since the matter is complex, grave and has a bearing on a vast section of the population, unlettered and with no real access to proper representation.
- 20. That the present application is bona fide and made in the interests of justice.

PRAYER

In the facts and circumstances, it is most respectfully prayed that this Hon'ble Court may be pleased to:

A. Allow the present Application and direct the office of the Coordinator to immediately take steps to ensure that no child is left out of the NRC

especially in cases where the parents/guardians/caregivers are in the list;

- B. Pending hearing and final disposal of the present Application, pass orders directing the Respondent State not to take any coercive action against the children or separate them from their families;
- C. And pass such other order(s) as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case.

AND FOR THIS ACT OF KINDNESS, THE PETITIONER AS IN DUTY BOUND SHALL EVER PRAY.




