JUDGEMENT

The Superintendent of police (B),  
Bongaigaon has referred the case to decide whether Usman  
Ali is an Illegal Migrant or not. The Local Verification  
Officer stated in his Annexure "A" report that father of  
the o/p was Registered as an ~~Registered~~ Elector in 1966. The  
o/p appeared and submitted his written statement and  
documents. The o/p was examined as D.W.I. The o/p was born  
at village Barbakhra under Bijni P.S in Bongaigaon  
District. His father and mother died while he was a Child.

DECISION AND REASON :-

as per Ex- A. N.R.C of 1951. As per Ex- B certified copy  
of voter list name of Jarimuddin Sk father of the o/p was  
listed in village Barbakhra under Bijni Circle in 1966  
under 42 Abhayapuri L.A.C.

It appears that o/p did not enter into India as an Illegal Migrant on or after 25-3-71.

The o/p is not an Illegal Migrant within the meaning of clause (C) Sub- Sec (I) of Sec 3 of the I.M. (D) T. Act. 1968.

The reference is decided in favour of the o/p.
