IA NO.49611/2025 (INTERVENTION/IMPLEADMENT) IN WRIT PETITION
(CRIMINAL) NO.234/2020

The learned senior counsel appearing for the applicant pointed out that the name of the applicant figures at serial no.18 on the list submitted by the Government of Assam of the foreigners who are to be deported. She states that the applicant has challenged the order of the Tribunal declaring her as a foreign national by filing a writ petition before the High Court. If that be so, it is for the applicant to seek appropriate interim relief from the High Court in that behalf. Therefore, at this stage, we are not passing any order on this Application.

WRIT PETITION (CRIMINAL) NO.234/2020

Shri Tushar Mehta, learned Solicitor General, on instructions, states that the issue of deportation of the foreigners which arises in this Petition is being dealt with at the highest executive level and if time is granted, he will place on record the decision taken by the appropriate authority. We grant him time till 21st March, 2025.
