Heard Mr. M. Dutta, learned counsel for the petitioner. Also heard Mr. R. K. D. Choudhury, learned DSGI, appearing for the Union of India, Mr. J. Payeng, learned standing counsel for the FT Matters, and Mr. P. Sarmah, learned Additional Senior Govt. Advocate for the State.

2. Pursuant to the order passed on 06.06.2025 and 09.06.2025, the learned Standing Counsel for the FT matters has submitted that Samsul Ali, the father of the petitioner, namely, Bakkar Ali has been handed over to the Border Security Force, BSF Sector Head Quarter, Panbari District-Dhubri on 26.05.2025.

3. Accordingly, it is provided that in the event, Samsul Ali, the father of the petitioner, namely, Bakkar Ali, has not been deported, the In-charge of the Sector Head Quarter, Border Security Force, Panbari, District-Dhubri shall, on production of a certified copy of this order, allow the visitation right to the petitioner along with one family member to meet his father Samsul Ali and to take his signature in the vakalatnama, if so required, which shall be authenticated by the authority who is In-charge of the Sector Head Quarter BSF,



Panbari, District- Dhubri.

4. It is further provided that in the event the father of the petitioner has been deported, the said authority shall inform the petitioner as to the location from which the said Samsul Ali, the father of the petitioner, namely, Bakkar Ali has been deported out of the Country.
