Heard Mr. M. Dutta, learned counsel for the petitioner. Also heard Mr. P. S. Bhattacharyya, learned CGC; Mr. H. Khuli, learned counsel appearing on behalf of Mr. A.I. Ali, learned standing counsel for the ECI; Mr. J. Payeng, learned standing counsel for the FT matters and Mr. P. Sarma, learned Additional Senior Government Advocate.

2. Pursuant to order dated 09.06.2025, Mr. J. Payeng, learned standing counsel, FT matters, has submitted that as per telephonic instructions received by him, the detained person, namely, Doyjan Bibi is currently being held at the Holding Centre in 7th Assam Police Battalion, Charaikhula, District of Kokrajhar.

3. Accordingly, the Court is inclined to provide the visitation right to the petitioner along with one family member to meet detained person, namely, Doyjan Bibi at the Holding Centre at 7th Assam Police Battalion, Charaikhula, District - Kokrajhar.

4. It is provided that a certified copy of this order be produced before the In-charge of the Holding Centre at 7th Assam Police Battalion, Charaikhula, District-



Kokrajhar, the said authority shall permit the petitioner and one family member of detained person to meet Doyjan Bibi and also to permit the petitioner to obtain the signature of Doyjan Bibi in the vakalatnama, which shall be authenticated by the said authority.
