Heard Mr. M. Dutta, learned counsel for the petitioner. Also heard Mr. B. Chakravorty, learned CGC, Mr. H. Kuli, learned counsel appearing on behalf of Mr. A. I. Ali SC, ECI, Mr. J. Payeng, learned Standing Counsel for the FT Matters and Mr. P. Sarmah, learned Additional Senior Govt. Advocate for the State.

2. Mr. J. Payang, learned standing counsel for the FT matters has submitted that although on the basis of telephonic instructions, he had informed the Court on 16.06.2025, that the Doyjan Bibi, the wife of the petitioner is in held at the Holding Center at 7<sup>th</sup> Assam Police Battalion, Charaikhula, in the District of Kokrajhar.

3. However, he has now received written instructions from the Senior Superintendent of Police, Dhubri, around 26.05.2025, Doyjan Bibi has been handed over to the Border Security Force, Sector Head Quarter Panbari, for her deportation to the Bangladesh.

4. Accordingly, Mr. B. Chakarborty, learned CGC, is requested to obtain information from the Border Security Force, Sector Head Quarter Panbari, as to the whereabouts of Doyjan Bibi, wife of the petitioner namely, Abdul Rejjak, against whom an *ex parte* opinion dated. 31.08.2017, was passed by the learned Member, Foreigners Tribunal 4<sup>th</sup>, Dhubri, Assam, in F.T.C/No.FT-4/71GPR/2017, arising out of
