Heard Mr. M. Dutta, learned counsel for the petitioner. Also heard Mr. K.K. Parasar, learned CGC; Mr. J. Payeng, learned standing counsel for the FT matters; Mr. G. Sarma, learned standing counsel for the NRC; Mr. M. Kalita, learned counsel appearing on behalf of Ms. P. Barua, learned standing counsel for the ECI; and Mr. P. Sarmah, learned Additional Senior Govt. Advocate for the State respondent.

2. By order dated 04.06.2025, this Court had directed the learned standing counsel for the FT matters to obtain information as to the whereabouts of the father of the petitioner, namely, Abdul Sheikh as to where he is presently lodged, if not already deported and in the event the father of the petitioner is deported, to obtain information as to the place from where the father of the petitioner is deported and the manner of deportation.

3. Upon instruction, the learned standing counsel for the FT matters has submitted that the father of the petitioner, namely, Abdul Sheikh is presently lodged in the Holding Centre under 7<sup>th</sup> APBn., Charaikhola, Kokrajhar.



4. On such disclosure being made, the Court is inclined to grant the petitioner, namely, Sanidul Sheikh along with a maximum 2 (two) other persons visitation right to the detained person, namely, Abdul Sheikh at the Holding Centre under 7<sup>th</sup> APBn., Charaikhola, Kokrajhar.
5. On production of certified copy of this order, the official, who is the in-charge of the said Holding Centre and having custody of Abdul Sheikh shall permit visitation right to the petitioner and 2 (two) others. The said authority shall also allow the petitioner to obtain signature of the detained person in the Vakalatnama to be duly identified by the said official.
6. On the next date of listing, the learned counsel for the petitioner shall inform the Court if the visitation right has been allowed.
