

Heard Mr. A.R. Sikdar, learned counsel for the petitioner. Also heard Mr. M.R. Adhikari, learned CGC; Mr. M. Islam, learned counsel appearing on behalf of Mr. A.I. Ali, learned standing counsel for the ECI; Mr. J. Payeng, learned standing counsel for the FT matters; and Mr. P. Sarmah, learned Additional Senior Govt. Advocate for respondent.

- 2. By order dated 06.06.2025, notice has already been issued which was made returnable on 11.06.2025.
- 3. The learned counsel for the petitioner projects that vide Annexure-4 to the writ petition, the petitioner has shown that his son, namely, Hachinur @ Hasinur, who was granted bail on condition to regularly appear before the Goalpara Police Station, has been attending the said Police Station and the attendance sheet by police personnel of Goalpara Police Station including the Officer-in-Charge of the said Police Station, appearance of the petitioner has been recorded on 05.05.2025 and 12.05.2025.
- 4. Therefore, if the son of the petitioner is complying with the order conditions of the order of the bail, the learned counsel has been able to make out a *prima facie* case.
- 5. Be that as it may, let a copy of the writ petition along with Annexure-4 be sent to the Officer-in-Charge of Goalpara Police Station, who on receipt of

the same shall verify the correctness of Annexure-4 and inform to the learned standing counsel for the FT matters about it.

- 6. To facilitate faster transmission of the information, the learned counsel for the petitioner shall provide a soft copy of the writ petition inclusive of Annexure-4 to the writ petition to the learned standing counsel for the FT matters so as to enable him to send a copy of the writ petition to the Officer-in-Charge of Goalpara Police Station and to the Office of the Superintendent of Police (Border) Goalpara.
- 7. In the meanwhile, on production of a certified copy of this order the In-charge of the Kokrajhar Holding Centre, at 7th Assam Police Batallion, Kokrajhar, shall permit at least 2(two) members of the family of Hasinur @ Hachinur who has been detained and currently held at the Kokrajahar Holding Centre at 7th Assam Police Battalion at Charaikhola in the district of Kokrajhar.
- 8. List the matter on 16.06.2025.
