Heard Mr. M. Dutta, learned counsel for the petitioner. Also heard Mr. R.K.D. Choudhury, learned DSGI for the Union of India; Mr. J. Payeng, learned Standing Counsel, F.T and Mr. P. Sarma, learned Additional Senior Government Advocate, Assam for the State respondent.

The learned Standing Counsel for the F.T. Matters has submitted that as per instruction received, Samsul Ali, the father of the petitioner namely, Bakkar Ali, has been handed over to the BSF. However, the particular post of the BSF, where the said person has been handed over, is not known. Accordingly, the providing of incomplete instruction to the learned Standing Counsel, FT Matters by the Border Police is not at all appreciated. The Superintendent of Police (Border), Chirang should have been well advised to provide complete and appropriate instructions to the learned Standing Counsel, FT Matters.

Accordingly, the Superintendent of Police (Border), Chirang Border on receipt of telephonic and/or any other form of communication from the learned



Standing Counsel, FT Matters, shall provide the complete information through Whatsapp /Telephonic app and/or any other Mode as to the particular post of BSF where Samsul Ali, the father of the petitioner, Bakkar Ali has been handed over and shall also provide the copy of memorandum prepared, if any.

On receipt of information/instructions, as referred above, the learned Standing Counsel, FT Matters shall share the information with the learned DSGI.

The learned Standing Counsel, FT Matters is permitted to transmit the downloaded copy of this order by Whatsapp and/or any other Mode to the Superintendent of Police (Border), Chirang.
