O R D E R

Today, certain suggestions have come from the side of the petitioner which are in nature of an apology.

Let a detailed affidavit be filed and the apology be given in Hindi language with the appropriate translation in English language as well (since we are given to understand that the petitioner's

mother tongue is Hindi). Such an undertaking is given by the Counsel of the petitioner today before this Court. Let an advance copy be given to Mr. K.M.Nataraj, learned additional solicitor general appearing for the State and also to Ms.Sonia Mathur, learned senior counsel for the complainant.

Mr. Nataraj, has also brought before this Court that certain social media posts which he would allege are still being posted, and are in any case subsequently to his present controversial post.

Learned senior counsel/counsel for the petitioner will also cross-check this fact and shall file a detailed affidavit to that effect as well.

Meanwhile, subject to the cooperation of the petitioner in the ongoing investigation, no coercive measure be taken against the petitioner till the next date of hearing.

Meanwhile, if any other offensive post(s) is given/made by the petitioner, the respondent-authority will proceed in accordance with law, and may also approach this Court for appropriate directions.

The State as also the complainant are permitted to file necessary documents if needed.
