O R D E R

W.P. (C) No. 460/2025

1. In deference to the order dated 05.05.2025, the Commissioner of Police, Mumbai (respondent No.11) has filed an affidavit regarding effecting service on respondent Nos. 6 to 10 and the proof of such service has also been attached.

2. Respondent Nos. 6 to 10 are present in Court in compliance to paragraph 2 of our order dated 05.05.2025. The counsel for respondent Nos. 6 to 10 seeks and is granted two weeks time to file counter affidavit, if any, for which no further time shall be granted. Rejoinder, if any, may be filed within one week thereafter.

3. Learned counsel for the respondent No. 4 also seeks and is granted two weeks time to file counter affidavit. Ms. Swikriti Singhania, learned AOR for respondent No. 5 also seeks and is granted two weeks time to file Vakalatnama and counter affidavit. Rejoinder, if any, may be filed within one week thereafter.

5. Respondent Nos. 6 to 8 and 10 shall remain present in person on the next date of hearing. Their absence will be viewed seriously. As regard to respondent No.9, keeping in view the peculiar circumstances, she is permitted to appear online on the date fixed.
