SUBJECT: Irregularities in Summary Revision (SR) Procedure of Assam Electoral Roll

Dear Madam/Sir,

With all due respect, we at *Citizens For Justice and Peace* along with other three organisations wish to bring to your attention multiple complaints that have surfaced regarding discrepancies in voter list updates during Assam's SR, including unauthorized deletions, ghost entries, and exclusion of legitimate voters.

This memorandum highlights multiple reported irregularities in the process of the ongoing Summary Revision (SR) process for Assam's electoral rolls, urging immediate investigation and corrective action.

Reported Irregularities

1. False objections raised in different districts of Assam, for example – Shribhumi (former Karimganj) and Goalpara.
2. Persons who are no more alive (Dead Persons) have filed objections against legitimate voters.
3. A woman of Jyotinagar, Krishnai namely Naba Bala Ray filed a staggering 64 (sixty-four) objections against legitimate voters of Goalpara Town. After receiving these notices all the victims of this irregular process went to her house and asked about her complainants. She vehemently denied any knowledge about having raised any Objections to these 64 Voters. Subsequently she withdrew some of these complaints with her Signature in Assamese and then also withdrew Complaints of Form 7, (at the time of withdrawing the complaint it is seen that her Signatures are appeared in FORM 7 in English Version according to her she does not know how to write in English). 4. A person namely Salim Ahmed of Shribhumi district filed an Objection against himself along with another 133 (One Hundred and Thirty Three) Voters stating that they are not genuine voters. It appears that these allegations are false and fabricated. He has told the BLO namely Sumana Choudhury that he has not filed any Complaint /Objections against any one.

5. Our team has reports that Prahlad Biswas General Secretary South Kamrup District BJP and ZPC member, Mrinmoy Boro, Secretary South Kamrup District BJP, Buddheswar Rava, General Secretary South Kamrup District ST Morcha, BJP and Mridul Talukder Vice President Assam Pradesh ST Morcha, BJP unauthorisedly entered the Office of the Co-district commissioner Boko-Chhaygaon, Kamrup and unauthorisedly accessed the Official Documents and Electronic Database of the Election Commission.

6. Some Objections filed against Voters who have not transferred their residence. However against them Complaints have been filed stating that they have been transferred. We have made a list of these which is annexed here to as Annexure 2

7. There are Other Complaints stating Voters who are very much living voter have been reported as dead by some fake Objectioner/Complainant. We request that the State Election Commission scrutinises this aspect also.

We, the undersigned, bring to your attention several concerns and demands related to the ongoing Special Revision (SR) of electoral rolls in Assam.

Prayers:

1. Withdraw Allegations: Withdraw all Objections if the Original Complainant is found absent in hearing.

2. Publish a free and fair Electoral Roll in the interests of democracy.

3. Address the Issues Faced by Migrant Labourer: Withdraw or dismiss Objections filed against migrant labourers from Assam who returned home during the Verification period and faced (renewed) Objections upon their return to work.

4. Ensure Impartiality: Ensure the impartiality of the Election Commission, particularly regarding allegations of interference by BJP workers in Boko-Chhaygaon constituency and instructions from Dilip Saikia and the statement of CM Himanta Biswa Sarma that is blatantly partisan.

5. Investigate the Misuse of Form 7: Investigate instances of false complaints filed using Form 7 and take action against those responsible. Examples have been given above.
6. Action against False Complainants: Hold false complainants accountable and compensate victims for mental, physical, or financial harassment.
7. Take Legal Action: Take action under Section 31 of the People's Representation Act, 1950, against those making false statements in the SR process.
8. Increase the time limit for the Claim Process and Publication of the Final Draft List.

We urge the Election Commission to address these concerns and ensure a fair and transparent SR process.
