1) Mr.Irani, learned Advocate appearing in Public Interest Litigation (L) No.11793 of 2025, tendered across the bar a compilation of documents with a covering letter dated 21st April, 2026, duly signed by Mr. H.B. Patel, elected councillor, Ward No.55, P/South Ward, Mumbai. Mr. Patel has expressed his grievance about the illegal hawking within the jurisdiction of P/South Ward, Mumbai.

2) Public Interest Litigation (L) No.11793 of 2025, is filed for implementation of the Judgment of this Court in the case of *The Maharashtra Ekta Hawkers Union Vs. Town Vending Committee - MCGM & Ors. in WP (L) No.29339 of 2024, and other connected Writ Petitions, dated 23rd March, 2026*, and to adopt necessary and appropriate measures to

implement The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014, and for other consequential reliefs, including relief of directing Respondents members therein to vacate all illegal hawkers from the vicinity of the places more specifically mentioned in prayer clauses of the Petition.

3) Mr. Irani, on earlier occasions in his arguments had also drawn our attention to the various complaints lodged not only by the Association of the Petitioner but also the complaints lodged by Mr. H.B. Patel, from time to time with the Municipal Authorities, of which as usual cognizance has not been taken by them and illegal hawking is flourishing.

4) Record indicates that, in Suo Motu Writ Petition No.1 of 2023, Mr. Kate, Superintendent of License, has filed an Affidavit dated 29th July, 2024. In the said Affidavit it is categorically stated that, the Officers of B.M.C. will take necessary steps for keeping away the illegal hawkers who are congesting the areas or streets atleast in the said 20 places, mentioned in the chart annexed to the said Affidavit.

5) It is a matter of common knowledge that, B.M.C. Officers have failed to honour their statements and illegal hawkers are occupying the streets.

6) In view of the letter dated 21st April, 2026, issued by Mr. H.B. Patel, of which we have taken cognizance, we deem it appropriate to appoint Mr. Jamshed Mistry (*amicus curiae*) and Mr. Chaitnaya Chavan, learned

Advocate appearing for B.M.C. as Court Commissioners to visit the first three places mentioned at page No.755 of compilation No.2 at Serial No.1, 2 and 3 which are in the vicinity of this Court immediately and submit their report to this Court at the end of the Board. The said survey shall be undertaken forthwith.

7) We direct the High Court Registry to make available a four wheeler vehicle immediately to enable Mr. Mistry and Mr.Chavan to travel from it.

8) We direct the Security Officer, High Court of Bombay, to provide all the necessary and requisite police protection to the said two Court Commissioners, acting under our directions.

9) Mr. Mistry and Mr.Chavan, Court Commissioners submitted the following note :-

“Visit by Court Commissioner to three areas as to set out on page no. 755 of Amicus Curie Compilation

1. CSMT upto Court – We walked and checked licenses of the hawkers and stall holders. By and large most of the hawkers had valid upto date payment made receipts alongwith the license copies. (Photographs and video evidence forwarded to court Associate).

2. Churchgate High Court – Hawkers were selling clothes, electronic items spectacles etc. They seemed to be informed of our visit and had kept license copies ready for

inspection. There was one hawker who had a license for the year 2031 (Photographs and video evidence forwarded to Court Associate).

3. Colaba Causeway- Rampant hawking on the Regal side onwards. No hawking at all on the the electric house side of the road. Hawkers were in very close proximity and except a few others had licenses which had expired. They kept saying they were surveyed hawkers. Some of their stalls had numbers on them. (Photographs and video evidence forwarded to Court Associate)”.

10) Record indicates that, in Civil Appeal Nos.4156-57 of 2002, in the case of *Maharashtra Ekta Hawkers Union & Anr Vs. Municipal Corporations, Greater Mumbai and Ors*, the Hon’ble Supreme Court in its Order dated 1st April, 2005 on internal page No.6 has held as under :-

“Office to issue notice to them as to why action in contempt should not be taken against them for instigating hawkers to act against Orders passed by this Court and for preventing implementation of the scheme framed by this Court. The Police is directed to give full and complete protection to the Municipal staff as and when they go to clear the hawkers as per the directions of this Court. It will be the duty of the Commissioner of Police, Greater Bombay to see that such protection is given. The Police Commissioner shall also ensure that there is regular patrolling to ensure that once the hawkers are removed from a particular place, they do not come back to that place. It appears that apart from a sum of Rs. 3,000/- provided for in our Order in the case of *Maharashtra Ekta Hawkers Union & Anr. vs.*

Municipal Corporation, Greater Mumbai & Ors. reported in (2004) 1 SCC 625, the Committee is demanding a further sum of Rs. 1,500/- from citizens' group or others who appear either to support or to object to the proposals being considered by the Committee. It is clarified that the Committee will not be entitled to charge any further or other amount from such persons or groups. All that the Chairman of Committee will be entitled to is the sum of Rs. 3,000/- as provided in our above said Order. The Committee must also work out a procedure by which the dates of hearing are made known to the public and the result or their decision is also made known to all parties particularly those who had participated before the Committee.

11) Despite the Hon'ble Supreme Court has issued directions in the year 2005. Today also, the Police Authorities are not following the same as a reason thereof and as noted earlier illegal hawkers activities are flourishing.

12) Smt. Anjali Helekar, learned Government Pleader submitted that, she took the charge as Government Pleader, High Court (Original Side), Bombay yesterday in the evening and seeks time to peruse record and take instructions from the Higher Authorities of the State of Maharashtra.

12.1) At her request, stand over to 28th April, 2026.
